### RoHS Compliance Declaration

We hereby certify that our products, listed below, are compliant with all requirements and exemptions set by the European RoHS 2.0 Directive 2011/65/EU & the European Delegated Directive (EU) 2015/863.


### REACH Compliance Declaration

We hereby also certify that the products, listed below, manufactured by TEKTELIC Communications are fully compliant with the related requirements of European Union Regulation (EC) 1907/2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH):

1. Under the structure of the REACH regulation, TEKTELIC is a manufacturer of “ARTICLES” to our EU customers (according to ECHA’s guidance for articles, hardware and electrical and electronic equipment shall be considered as articles). We do not manufacture “substances” or “preparations” and our articles do not involve the “intentional release of substances”. Accordingly, we foresee no registration or pre-registration or Authorization requirement for the products we supplied.
2. With regard to the requirements of Article 33 of REACH: Duty to communicate information on substances in articles. We declare that none of the SVHC (the Candidate List of Substances of Very High Concern for authorization currently released by ECHA till the date of January 12, 2017, please refer to Note #1) is present in TEKTELIC products or packaging in quantities totaling in a concentration equal to or above 0.1% by weight.
3. With regard to the requirement of Article 67 of REACH: A substance on its own, in a preparation or in an article, for which Annex XVII (see Note #1), contains a restriction shall not be manufactured, placed on the market or used unless it complies with the conditions of that restriction. We declare that none of the substances in the conditions of restriction is present in TEKTELIC products or packaging.

As REACH regulations are updated frequently, for the major changes such as the addition of SVHC substances listed in Annex XVII, TEKTELIC will evaluate the update, and in time, update the declaration to reflect these changes.
